### **REVISED 2013 ANNUAL GDP AND 2014 PROVISIONAL GDP ESTIMATES**

### **INTRODUCTION**

Gross Domestic Product is the estimate of the total value of final goods and services produced in the country during a period.

The estimation of the Gross Domestic Product (GDP) is done in stages, with estimates generated at each stage being dependent on available data. Estimates from each stage are progressively designated as projected, provisional, revised and final.

This release contains the provisional estimates for 2014. The estimates for 2014 used data covering three quarters of the year from production units adjusted to cover the whole year, and also targeted annual production of some economic entities. Further revisions to these estimates will be carried out in April 2015.

### **KEY FINDINGS**

Provisional GDP estimates for 2014 showed a growth of 4.6 percent over the 2013 revised estimates. The Agricultur recorded the highest growth of 5.6 percent, followed by Industry (3.7%) and the Services sector with a growth of 4.9 percent. Though the estimates show an improvement in the growth of the Agriculture sector, its share of the structure of the economy continues to decline, with its share reducing from 22.3 percent of GDP in 2013 to 21.4 per Crops, however remain the largest activity in the economy with a share of 15.9 percent of GDP.

In the Industry sector, the least growing sector with a share of 25.0 percent, the growth declined from 6.6 percent in 2013 to 3.7 percent in 2014. Of all the industrial activities the Construction subsector recorded the highest growtl of 7.4% in 2014. Without Crude Oil, the GDP (now called "Non-Oil GDP") growth rate declines from 6.5 percent in 2013 to 4.6 percent in 2014. The Industry sector also declined from 6.6 percent (2013) to 3.7 percent (2014) and the Sevice sector from 9.9 percent to 4.9 percent.

Services remain the largest sector, sharing (53.5%) of GDP. The sectors growth rate however decreased from 9.9 percent in 2013 to 4.9 percent in 2014. Two of the subsectors in this sector recorded growth rates above 10 percent. These sectors are Financial and Insurance and Public Administration & Defence, Social Security activities
